Mr. Worthy expressed appreciation to Mr. Parker, Ms. Borrero and Mrs. Mullinax for their deep dive into this contract. He stated he had concerns about the ranking and that he would be a 'no' vote because he still does not know what the financial benefits are to the Authority. This may not be the time to make such a giant change. He further noted management did everything he asked to address his concerns, but this procurement is different than anything else as it addresses the safety, health and welfare of MARTA employees, which is one of the most important missions the Board have as fiduciaries. Changing payors without a substantial benefit to the Authority is troubling. He thanked staff for the work they did in bringing in a third party.

Mr. Ashe and Mr. Worthy voted no. Ms. Abdul-Salaam abstained.
